The Rock Dell Town Board met Monday, June 14, 2021 at 7:00pm at the Rock Dell Town Hall. Those officers attending were Supervisors Mike Meyers, Betsy Kleinwort and Terry King, Clerk Brenda Lindquist and Treasurer Dave Siljenberg. Also attending was Josh Davis.

Brenda read the minutes of the May meeting. The minutes were approved as read. Dave gave the treasurer's report. Income for the month was \$2.37 bank interest. Checks written in the amount of \$16,504.57. Ending balance of \$152,472.29. Treasurer's report approved as given.

Brenda gave a chloride report. 36 residents requested chloride application. As of today, Freeborn's bill was \$7,209.00. 2 residents were missed the first time around. Total amount received from resident's was \$7,196.00. 8,010 gallons were applied.

80<sup>th</sup> St in section 17, road needs to be fixed. Terry King will contact Larry Severson for consulting and retrieve an estimate.

American Rescue Relief was discussed. Rock Dell Township will be designated around \$70,000. 50% of funds in 2021, 50% of funds in 2022. Terry King made a motion, seconded by Betsy Kleinwort to pass the resolution to accept the corona virus local fiscal recovery fund established under the American Rescue Plan Act; motion failed with 3 nah votes.

Ditch needs to be cleaned out by Bryan DeCook's place. Terry King will contact Larry Severson for consulting and estimate to fix.

Terry King gave an update on TCPA meeting. Mike Meyers gave an update on the association meeting.

Claims reviewed. Mike Meyers made a motion, seconded by Betsy Kleinwort to pay all other claims; motion carried with 3 yea votes. Checks were signed.

Brush spraying was discussed. The designated areas were sprayed on June 10<sup>th</sup>. The designated areas don't seem to be showing signs of being sprayed. The board decided to wait until the next meeting to see if more weeds have died. The board would like North Star Property Solutions to come back at our August meeting to explain more of the process.

Bob Faulhaber had placed a electric fence in Rock Dell Townships right-a-way right up to the road. Betsy Kleinwort had stopped to advice him that the fence must be moved right away. Betsy Kleinwort will check on Friday to see if it has been moved.
